### NEW YORK STATE VETERANS' AFFAIRS COMMITTEE LEGISLATIVE UPDATE

"Bad Papers—Many veterans received less than honorable discharge as a result of Traumatic Brain Injury (TBI), Post – Traumatic Stress Disorder (PTSD), Military Sexual Trauma (NST), or a result of sexual orientation, gender or expression, pursuant to the federal Don't Ask Don't Tell Policy. These discharges were determined on the federal level and cannot be revised by the State. However, a number of State benefits require an honorable discharge. This bill would ensure that LGBT veterans and veterans with certain qualifying conditions are eligible to receive State benefits. (Passed Both Houses; A.8097/S45-B)

Discharge Upgrade Advisory Board Program— The bill will require the Division of Veterans' Services to maintain a Discharge Advisory Board Program to provide written non-binding advisory opinions to veterans of the State of New York who are appealing their character of discharge from the United States Armed Forces. (Passed Both Houses A.8095-A/S.6467)

Assisting Veterans With Military Discharge Upgrades—Local veterans' service agencies are required under this measure to assist veterans in the process of submitting an application for a discharge upgrade to the Discharge Advisory Board Program at the New York State Division of Veterans' Services. (Passed Both Houses; A.8096/S6527)

Pension Poaching Prevention Act—This legislation would prohibit any person helping veterans from charging a fee for providing assistance in seeking veterans' benefits, except when allowed by rules and regulations promulgated by the U.S. Department of Veterans Affairs.

(Passed Both Houses; A.6292/S4807)

Women Veterans Coordinator--The purpose of this bill is to clarify and update the duties of the women veterans coordinator within the New York State Division of Veterans' Services. (Passed Both Houses; A.7594/S5991)

Information on Special Veterans Populations—The Veterans Health Information Program provides a list of resources for veterans, their families, and health care providers seeking information on service-connected illnesses. This legislation would expand the Program's depth of practice to include conditions such as Post-Traumatic Stress Disorder (PTSD), brain-injury injuries, and spina bifida. Also included in this legislation is a requirement to include military background and circumstances of the veteran who are under the jurisdiction of the Department of Corrections and Community Supervision. (Passed Both Houses; A.1804/S.2377)

Assistance for Sexual Trauma in the Military—To provide information to veterans regarding resources that are available to assist veterans who experienced military sexual trauma while on active duty or during military training, by maintaining a military sexual trauma portal on the Division of Veterans' Services website. (Passed Both Houses; A.2559-A/S.5006-A)

Listing of County and City Veterans' Service Agencies---Veterans' services exist not only in State government but on the local level as well. To better facilitate accessibility to local veterans' service agencies, this legislation would require to New York State Division of Veterans' Services to post on its website a listing of the local veterans' service agencies with the name, location, hours of operation and contact (Continue on pg. 6)

Information for each county and veterans' service agency in the State. (Passed Both Houses; A.4413/S.2405)

Information on Homeless Veterans—The purpose of this bill is to conduct a study to determine the number of homeless veterans in New York State in order to understand the extent of this problem. (Passed Both Houses; A.5560/S.4049-A)

Mobile Application For Searching Veterans Services—To require the New York State Division of Veterans' Services to post on its website information to the Division of Veterans' Services applicant that is available for down load. (Passed Both Houses; A.6792-A/S.4477-A)

Severely Injured Military Personnel Tax Exemption—The purpose of this bill is to establish, at local option, a real property tax exemption for severely injured members of the Armed Forces of the United States who continue their military service and have made accessibility improvement to their existing homes. (Passed Both Houses; A.7289/S.1681)

Establishing the Outdoor Rx Act–Requires the New York State Division of Veterans' Services in consultation with the Office of Parks, Recreation and Historic Preservation, the Department of Environmental Conservation, the Department of Health and the Office of Mental Health to review issues relating to veterans' abilities to access state parks, lands and facilities. (Passed Assembly only; A.8094)

Peacetime Veteran- To provide those veterans who have served during peacetime to be eligible for the position of a County Veterans Service Agency director if he or she meets all other qualifications. (Passed Assembly only; A.7573)

### Kevin Gorman: Rocky Belier's return to Vietnam gives new perspective

When Rocky Bleier surveyed the open rice paddy at Hiep Duc in the Que Son Valley last August, the Pittsburgh Steelers great tried to visualize the differences of nearly five decades.

"Jesus Christ," Bleier said, stopping in his tracks. "You think about those guys that got killed."

Bleier sniffled, then started sobbing, his hands trembling.

"For what?"

Forty-nine years to the day he was wounded by gunshot and grenade shrapnel, Bleier's return to Vietnam brought an emotional breakdown he never anticipated.

Bleier's raw vulnerability – and the unexpected, dramatic moment that followed – was captured by a camera crew and makes for a powerful scene in the SC Featured documentary, "The Return."

"All of a sudden, I had this overwhelming sense of emotion that I really couldn't put a finger on of why or what took place," Bleier told the Tribune-Review on Friday. "What I felt was this complete sense of waste — not loss, but waste. Why? Fifty-nine thousand died in Vietnam, for what? That was my justification or reason why it was overpowering. And I still feel that now."

Regarded as one of the "grittiest players" on the Super Steelers of the 1970s, Bleier had been adamant beforehand that he carried no emotional scars — only to be moved to tears.

"You knew his demeanor going into that. He was like, 'I don't know if there's anything there but we'll see,' " said Jon Fish, who directed and produced "The Return."

"As a filmmaker, we were just willing to roll the cameras and see what happens. ... When it happened, it was really powerful. It was just really powerful, and we just let it happen."

"The Return" is scheduled to air a shortened version on SportsCenter this weekend and the full 30-minute documentary on ESPN2 at 8 p.m. Aug. 20. That coincides with the 50th anniversary of the mission by 33 men from Charlie Company 4th Battalion (Light), 31st Infantry 196th Light Infantry Brigade to recover the bodies of nine soldiers killed in an ambush. Four more soldiers died, and 25 others, including Bleier, were wounded when they emerged from a wooded trail to face enemy fire in that open field in Hiep Duc.

Bleier was awarded the Bronze Star and Purple Heart after he was shot in the left thigh, lost part of his right foot and took shrapnel in both legs. The documentary, reported by ESPN's Tom Rinaldi, is a moving tribute to Bleier interrupting his NFL career to serve in the Vietnam War and his courageous comeback.

"No one told me no," Bleier said, simply.

Not that he would have listened anyway.

"How can you not admire Rocky Bleier?" Terry Bradshaw said. "He had a dream, and he wasn't going to quit on it. That's the kind of people you want to play with."

The storytelling is splendid, from scenes of the Steelers winning four Super Bowls to Bleier's touchdown catch against the Dallas Cowboys in Super Bowl XIII gracing the cover of Sports Illustrated.

The interviews, from Art Rooney and Joe Greene to Bradshaw and especially Franco Harris, are incredible. Fish found it amazing that almost everyone he interviewed connected to Pittsburgh is in the Pro Football Hall of Fame.

While Bleier's story was a worthy subject on its own, what makes it powerful is the depth it delves into finding fellow soldiers from the Vietnam War, including one who fought for the Viet Cong. Where Bleier initially downplayed the idea, one that was a decade in the making, it gave him a new perspective.

"For people that knew the story, this is a new layer to it. For people that didn't know the story, they're blown away. That's the wonderful thing about the story," Fish said.

"Rocky Bleier now is the same Rocky Bleier who came back after being wounded to make the Pittsburgh Steelers. The essence of him then is the same as now: We're going to come back, and we're going to finish this story. You see the power and inner strength that he has, that started the story way back when. Years later, he's the same person."

Except that Bleier isn't. He admits the visit to Vietnam – something he never felt a desire to do – changed him for the better. That was especially true when, a month after returning, he was inducted into the Steelers' Hall of Honor. It made him realize how blessed he was to survive and succeed.

"That's what we all want, to be recognized for your contribution along the way," Bleier said. "It doesn't mean you need to be in the Hall of Fame or an All-Pro, just that somebody recognizes that you put time and effort in and you played on a team that allowed you to be in position to win four Super Bowls.

"It's not you. It's that conglomeration of you and the owners, coaches and players you got to be part of. Hopefully, you can look back and say, 'I made a difference in the lives of my kids, community, church, marriage' or whatever it may be. That becomes essential, that you did something worthwhile."

What is most essential to Bleier is those who watch "The Return" can make sense of the senseless by starting a conversation that will help them find their own closure toward the Vietnam War, which has touched all of our lives, whether that's through a family member or a friend.

"Unlike the majority of Vietnam veterans at that time, who came back to a hostile environment here in the States and weren't appreciated for their service — and they had nobody to talk to or talk about and had to suppress their feelings — I came back and became a story," Bleier said. "That was somewhat of a catharsis for me, that I had to talk about those feelings and everything that had taken place. And I've been telling that story for 50 years."

"The Return" tells Bleier's story in a new way, with a moment of weakness actually showing his strength.

#### Pending Bill: S.1881 - Veterans Expedited TSA Screening Safe Travel Act

Introduced in Senate (06/18/2019) 116th CONGRESS 1st Session S. 1881

To provide PreCheck to certain severely injured or disabled veterans, and for other purposes.

#### IN THE SENATE OF THE UNITED STATES

June 18, 2019

Mr. Young (for himself and Ms. Duckworth) introduced the following bill; which was read twice and referred to the Committee on Commerce, Science, and Transportation

A BILL: To provide PreCheck to certain severely injured or disabled veterans, and for other purposes.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, SECTION 1. Short title.

This Act may be cited as the "Veterans Expedited TSA Screening Safe Travel Act" or the "VETS Safe Travel Act".


SEC. 2. Availability of PreCheck Program to certain severely injured or disabled veterans.

(a) In general.—Section 44927 of title 49, United States Code, is amended by adding at the end the following:

"(g) Availability of PreCheck Program to certain severely injured or disabled veterans.-

"(1) IN GENERAL.—A veteran described in paragraph (2) is eligible for security screening under the Pre-Check Program under section 44919 at no cost to the veteran if the veteran is able to meet the background check and other security requirements for participation in the program.

"(2) VETERANS DESCRIBED.—A veteran described in this paragraph is a veteran determined by the Secretary of Veterans Affairs— "(A) (i) to have had a loss, or loss of use, of a limb; "(ii) to have become paralyzed or partially paralyzed; or "(iii) to have incurred permanent blindness; and "(B) as a result of that loss, paralyzation or partial paralyzation, or blindness, to require the use of a wheelchair, prosthetic limb, or other assistive device to aid with mobility.".(b) Coordination on implementation.—Not later than 180 days after the date of the enactment of this Act, the Administrator of the Transportation Security Administration and the Secretary of Veterans Affairs shall jointly— (1) develop and implement a process for providing the Transportation Security Administration with access to the data needed to validate the eligibility of a veteran for the PreCheck Program (Continue on pg. 13)

Named committee: "Veterans Helping Veterans" have initiated beginning in 2013, a gift donation program to assist returning combat injured disabled veterans. The chapter committee has engaged with the U.S. Department of Veterans Affairs located in Castle Point, NY in conjunction with the supervisor prosthetic representative, and the chief of health care voluntary service.

These donations are in the form of handcycles which are used for rehabilitation and recreational use. Handcycles have been designated for a particular use; the first one to be donated to the Adaptive Sport Center at Castle Point, NY courtesy of the Military Order of Purple Heart, will be used for training purpose's. The item selected, topend speedcycle handcyle is the option of choice for training and rehabilitation by these veterans.

The second handcycle donated by VVA Chapter 333 was chosen and designated for a wounded Afghanistan veteran who suffered an above knee amputation. Sgt. Freddie Delos Santos was severely wounded in October 2008, serving as a gunner on a humvee; they took a direct hit from an enemy RPG during patrol. He has since become an avid competitive speed racer with many contest entered along with many victories.





VVA Chapter 333 is both humbled and honored to participate in this program, we look forward to both build and expand on this endeavor.

Another hand cycle presentation was made by VVA Chapter 333 on June 6, 2015 to another injured Iraqi war veteran. Retired Staff Sergeant Edwin Quiros received spinal cord injuries along with TBI (traumatic brain injury) in addition to a severely damaged right leg that has resulted in fusion of his foot and ankle. Edwin now participates in marathon races with his new cycle and actually won the first race entered!

As of this date 08/01/2019 the program has purchased and donated thirteen HAND CYCLES inclusive of one Mountain Bike, one Kayak with trailer and now an Outrigger Canoe for yet another disabled veteran. We have also provided safety gear for these veterans in the form of helmets, gloves, and other accessories. Chapter 333 HAND CYCLE PROGRAM is a success due to the members and nonmember volunteers who provide their time and effort in making another veteran's life who is in need just a little brighter.

We have been informed of a fund that has been established to care for veterans from all United States military service branches who are catastrophically wounded, ill or injured from combat operations in Vietnam.

Eligibility Criteria is as follows:

- Blind /legally blind ALS (Lou Gehrig's Disease) Amputation (loss of any limb or extremities)
- PTSD (combat related) 70% or greater VA rating Paralyzed (paraplegia, quadriplegia, hemiplegia)

• Severe Traumatic Brain Injury (cannot function independently) • Severe illness linked to Agent Orange exposure (recognized by the VA)

- Copy of DD214
  Photo ID
  LCpl Parsons Welcome Home Fund Application
- VA rating decision letter/ or signed note from medical provider stating diagnosis

Two recent articles one by the "Times Magazine" and the second by "NHK World" – NHK (Japan Broadcasting Corporation) covered the recent arrangement between the U.S. Agency for International Development (USAID) and Vietnam's Ministry of National Defense for Agent Orange Clean – Up (in Vietnam.

It has been reported that a 10-year project at Bien Hoa Airport outside Ho Chi Minh City has begun. Bien Hoa was one of the main depots for storing Agent Orange during the war and was only partially cleaned at the end of the war. The dioxin contamination at Bien Hoa is thought to be four times higher than at Da Nang.

The U.S. House Committee on Veterans' Affairs has passed eighteen (18) bills out of committee. The committee worked on suicide prevention, homelessness, and delivering justice for our Blue Water Navy veterans. All bill language can be found on the Committee Repository. From the first day that I began in the position of New York State Chair for Veterans Incarcerated and in the Justice System I have noticed a shift in the inquiries of our incarcerated veterans. More and more I have questions directed to me with respect to transitioning out of corrections and back into society. The services that are asked about the most are job placement services and homeless service providers. The National Coalition for Homeless Veterans – a not for profit corporation- has produced a small booklet that is intended to act as "A Guide for Incarcerated Veterans." When asked, I provide a copy of this resource to any Correctional Facility that wants one.

In New York State there are three organizations that provide employment preparation and job placement services that I am aware of. They are: The Doe Fund Inc., Brooklyn, NY 212-628-5207; Goodwill Industries of Greater New York and Northern New Jersey Inc., Astoria, NY 973-481-2300 extension 222; and Urban Youth Alliance International Inc., Bronx, NY 973-481-2300 extension 222.

If anyone is aware of other organizations that provide services such as employment preparation, job placement services and homeless services for our men and women veterans transitioning out of Corrections and back into society please contact me with the information and I will share it on a State wide basis to help get the word out.

## Agent Orange Report Bill Patton No Decision Yet From VA on New Agent Orange Presumptive Diseases

The VA has not announced any decision on whether it will provide disability compensation for four diseases linked to exposure to Agent Orange by a scientific panel, breaking a pledge to make a decision by late June. Despite a promise in March from a Veterans Health Administration official that VA would decide within 90 days whether to add four health conditions – bladder cancer, hypothyroidism, hypertension and Parkinson's

like symptoms -- to a list of diseases presumed related to herbicide exposure, a VA spokesman said last week that none is forthcoming "We have no announcements on Agent Orange presumptive conditions at this time," a VA spokeswoman said Wednesday, three months after a hearing in which a VA official told a senator the decision was pending. During a Senate Veterans Affairs hearing March 26, Dr. Richard Stone, the executive in charge of the Veterans Health Administration, said it was his "hope within the next 90 days that we'll have some decisions made. In March 2016, the Institute of Medicine, an arm of the National Academies of Sciences, found evidence that two conditions, bladder cancer and hypothyroidism, are likely linked to Agent Orange exposure and that a third, Parkinson-like symptoms, should be added to the list of diseases presumed to be related to contact with the herbicide. In November 2018, the organization, the National Academies, released a report finding sufficient evidence to link high blood pressure with exposure to Agent Orange. Hypertension previously had been designated as having limited or suggestive evidence that it could be related to contact with Agent Orange. But high blood pressure is so common among older Americans that it has never been added to the presumptive list. Having a diagnosis of a disease on the VA's presumptive list allows a veteran to bypass a requirement to prove that their illness is service-connected to receive disability compensation. Instead, they only need to prove that they served in an area where defoliants were used. In late 2017, former VA Secretary Dr. David Shulkin said he had decided whether to add several conditions to the presumptive list, and VA sent a recommendation to the Office of Management and Budget regarding the decision. But no further action was taken. Responding to a question from Sen. Sherrod Brown, D-Ohio, during the hearing, Stone said VA is working "through this right now," adding that the recommendation will go to VA Secretary Robert Wilkie for final approval.

### Veterans

1. Enroll in the VA system

2. Make an appointment for Agent Orange health exam by contacting your local VA environmental health coordinator. The registry evaluation is separate from VA's disability compensation process and does not confirm exposure during service.

3. Obtain your full military records with the assistance of an accredited service officer

4. Make copies of your military records for your children, with instructions to keep them safe and pass them along to your future generations. Your families will need your records for compensation requests.

5. Talk with your children/grandchildren. Tell them where you were, what you did, and let them know of the toxic exposures associated with your service.

6. Educate your physicians. If your physicians are not in the VA health care, inform them of your military service and toxic exposures; request that your military health history be included in

your medical records.

### **Families**

1. File a claim for the children and grandchildren. If you believe your child or grandchild has a health issue that may be linked to your exposure while serving in our nation's armed forces, have them file a claim with the assistance of an accredited veteran's service officer. Expect these claims to be denied!!! The important thing is to get these kids registered in the VA system. The claims are filed on the VBA form 21-0304 and are sent to the VA regional office in Denver, Colorado. The children's claims are not processed with the veteran's claims and do not add to the veteran's claims backlog.

2. Educate your physicians. Inform them of your parent or grandparent's military service and toxic exposures; request that this military health record be included in your medical records.

3. Collect and protect your full medical records as well as your veteran's military and health records.

4. Register with birth defects research for children. Have your children and their children complete the birth defects registry at www.birthdefects.org. Headed by Betty Mekdeci, BDRC is an independent organization that has been tracking the health of the children and grandchildren of veterans. Telephone number: 407 -895-0802.

5. Share your story to alert legislators and the media to this ongoing legacy of war. We are collecting real stories about people. If you wish to share your family's health struggles that you believe are related to military toxic exposures, send your story via email to mporter@vva.org.

My fellow Vietnam veteran's, we are now engaged in a fierce battle for the innocent victims of all wars, our children and grandchildren.

Based on the thousands of anecdotal accounts we have recorded from veterans and their families, we strongly suspect that the children, grandchildren, and in some cases, great grandchildren are manifesting a range of health issues suspected to be as a result of a parent's exposure to toxins while serving in the armed forces.

While our exploration has centered on the families of Vietnam veterans, the veterans of more recent wars also report health issues in their children.

#### Wait continues on additions to VA's Agent Orange connected illnesses

"They told us they were ready to go, and we haven't gone anywhere," said Rick Weidman, executive director for policy at Vietnam Veterans of America. "It feels like they just don't want to spend any money on this." Vietnam veteran advocates feel a sense of urgency because the the young-

est who served there are in their early 60s.

Last November, researchers from the National Academies of Sciences, Engineering and Medicine announced they had compiled "sufficient evidence" linking hypertension, bladder cancer, hypothyroidism, and Parkinson's-like symptoms with exposure to Agent Orange and other defoliants used in Vietnam and surrounding countries in the 1960s and 1970s.

The VA's approach differs sharply from the Pentagon's, which won an exemption for active-duty members of the military.

Top officials of the Department of Veterans Affairs declined to step in to try to exempt veterans and their families from a new immigration rule that would make it far easier to deny green cards to low-income immigrants, according to <u>documents</u> obtained by ProPublica under a Freedom of Information Act request.

The Department of Defense, on the other hand, worked throughout 2018 to minimize the new policy's impact on military families.

#### **Burn Pit Research Expands**

veterans of operations in Iraq and Afghanistan should have a greater chance of proving that exposure to toxins in burn pits made them sick. The VA is ramping up operations at its recently established Airborne Hazards and Burn Pits Center of Excellence. Information gleaned from research at the New Jersey-based facility would be used to formulate appropriate responses to veterans' claims relating to burn pit exposure.

#### For the First Time Ever, a Federal Court Allows a Whole Class of Veterans to Sue the VA

As reported June 18 by Abbie Bennett for Connectingvets.com, a lawsuit seeking relief for veterans facing long wait times for disability benefits appeals was allowed to move ahead, a federal court ruled. It's the first time a class-action lawsuit against the VA has been allowed by the court. The U.S. Court of Appeals for Veterans Claims last week ruled that the case could continue, which legal experts say could open up opportunities for similar cases against the Veterans Administration. Last August, the CAVC ruled that class-action suits in "appropriate cases" would be allowed against the VA, but none had risen to that level until *Godsey v. Wilkie*.

#### VA Privatization Bill Threatens Closure of Key Facilities

In a June 25 article for *American Prospect*, Susan Gordon and Russell Lemle recount how Republican architects of the *VA MISSION Act* want to fast-track a commission that would have expansive authority to close VA hospitals. At a June 20 House Committee on Veterans' Affairs hearing, legislators considered H.R. 3083, which will accelerate privatization of the VHA by changing the launch date of one of the most problematic parts of the *VA MISSION Act*—the Asset and Infrastructure Review Commission. The *VA MISSION Act* mandates the creation of an Asset and Infrastructure Review Commission whose nine members are appointed by the president. These appointments are supposed to include at least three members of veterans service organizations, as well as health-care industry representatives, and other key stakeholders. At the signing ceremony for the *VA MISSION Act*, President Trump insisted he would not be bound by this provision, while simultaneously praising the legislation.
